




1	Farmers seem intent on cutting down trees. It might be helpful to offer suggestions on the value of leaving trees standing along hedgerows and property lines.
2	I am pleased that you have sent out this survey. Sharon Township needs to protect the trees along the River Raisin .
10	The trees in my community play an enormous role in the beauty, peace and enjoyment of living in Sharon Twp. I regularly walk the scenic dirt roads and the trees provide beauty, shade and wind block. Occasionally a tree will fall across the road but neighbors are very quick to cut and remove them. I definitely do not want trees removed along the edges of the roads. They help with dust and noise control for homes and provide privacy which is highly valued. Sharon Twp has some very scenic roads in part due to the many trees.
